FRESH CHECK DAY HELPS TO BUILD A BRIDGE BETWEEN STUDENTS AND THE MENTAL HEALTH RESOURCES AND PROGRAMS THAT EXIST ON CAMPUS, IN THE COMMUNITY AND ON A NATIONAL LEVEL.
